4. Administrator's Report:

Dr. James Johnston.

15 days remain in the legislative session and there is a lot of activity at this time. There are a few things being watched closely with some concern, one of which is SB 494. Institutions could not raise tuition once a budget is approved, which on its face appears appropriate. The Board of Regents, however, have the right to adjust tuition independent of the budget approval and this bill infringes upon their rights as a governing body of ENMU.

ENMU receives monies as a participant of the RPSP grant. The legislature is looking to move some funding from the RPSP to the ING. This may stabilize funding for programs, but it is unclear on the greater outcome. ENMU has agreed to participate in a study with other institutions to determine the impact of such a move.

ENMU has great representation during the Higher Education Day at the legislature. Once the legislative session has concluded, Dr. Johnston intends to meet with departments and colleges as to programs and their strengths to get a clearer vision for university efforts.

A senator asked about faculty salaries and the short answer is this has yet to be determined. There is a state increase planned, but the outcome of the additional \$7m for faculty salaries is still unknown. How this money will be distributed, if received, is unclear at this time. As he learns more he will share.

Dr. Jamie Laurenz.

Academic freedom is on our agenda today and he is excited to talk with us about it. The original point was an interest in including it during the NFIP. He would gladly entertain this if faculty senate would like it included. As to whether there is a university policy, the answer is no. Academic freedom is codified in the faculty handbook and aligned with the AAUP standards.

With freedom, however, comes responsibility. Academic freedom has three tenets: research and inquiry, teaching and expression. He understands the inquiry around this to be focused on freedom in the classroom and dictated content concerns. Outside entities, such as the legislature, do not have content oversight but curricular content can be determined by faculty as a collective sense as a program body, or even outlined by an accrediting body to meet national standards. As singular faculty, you are teaching a curriculum and curriculum builds as it progresses through a program. Program and student learning outcomes are a collective responsibility of faculty. Syllabi are a great example of this, they are great for students to outline course objectives and expectations. They are also an accreditation requirement.

Another example is the online course standards, crafted in response to the Higher Education Department's request for institutional oversight. These were crafted in partnership with the faculty in administration as a function of the shared governance that ENMU operates with. All entities of curricular oversight (Assessment, Program Review, Distance Learning) are represented by faculty and supported by administrative staff to continue this process. He welcomes this discussion and looks forward to the Senate's decision on the NFIP.
