OTHER BUSINESS

1. Action Regarding the Appointment of Chancellor/President and Approval of Employment Agreement

Regent Lance Pyle said the Regents have met in Executive Session numerous times during the month of November. After input from faculty, staff, community, and students, they have reached an agreement on Dr. James N. Johnston as the next President/ Chancellor of Eastern New Mexico University.

Dr. Johnston has agreed to the terms outlined in the employment agreement. The contract term is two years, commencing on January 3, 2023, and terminating no later than January 2, 2025. The salary is \$268K, payable in 26 bi-weekly installments, beginning January 20, 2023. Standard contract language was used from the previous presidential employment agreement.

Regent Ruiz moved to approve the appointment of Dr. James N. Johnston as President/Chancellor of Eastern New Mexico University and approved the employment agreement as presented. Regent Bustos seconded the motion. Vote: 5-0-0. Motion approved.

Regent Pyle introduced Dr. Johnston, who joined the meeting virtually.

Dr. Johnston thanked the Regents for entrusting this outstanding University to him. Throughout this process, he was very impressed with the great work being done systemwide and now looks forward to the things we will do together. He stated that he was also impressed with the people committed to the search process and the respect and openness he perceived from faculty, staff, students, and community members.

Dr. Johnston said he and his wife, Stephanie, are truly honored to become members of the Greyhound family.

2. Turfing of the Softball Outfield

Mr. Tony Major stated they are asking for up to \$400K for the Women's Softball Field outfield turfing project. The infield was returfed over the summer, resulting in a rift between the infield and outfield that this turfing will correct.

The University is prepared to seek approval from NMHED upon Regent approval and has resources to address the project.

Regent Ruiz moved to approve the turfing of the softball outfield as presented. Regent Pyle seconded the motion. Vote: 5-0-0. Motion approved.

3. Award of Posthumous Degree to Analuisa Mendoza

Dr. Jamie Laurenz said on October 13, 2022, students Analuisa Mendoza and Alicia Bustos were tragically killed in a crash near Amarillo, TX.

Ms. Mendoza was completing her associate degree this December, with plans to pursue a career in law enforcement. She had completed 72 hours toward her degree, and her

parents, Luis and Rome Mendoza, have requested that Analuisa's degree be awarded posthumously.

Regent Patterson moved to award a posthumous degree to Analuisa Mendoza as presented. Regent Ruiz seconded the motion. Vote: 5-0-0. Motion approved.
