1. <u>Increase in FY27 RPSP Request for KENW</u>

Dr. James Johnston said the state invited ENMU to request an increase in state funding for KENW to offset the anticipated Federal loss for the upcoming budget cycle. A request for \$1.28 million was presented.

Discussion took place regarding the effect this loss could have on KENW, students, and the viewing area if alternative funding measures were not found.

2. ENMU-Roswell Architect Selection for AMT Building Expansion

Dr. Shawn Powell presented an approval request for architectural services by Parkhill Architects of Albuquerque for the 2024 General Obligations Bond project. This project expansion is for the Aviation Maintenance Building, and the anticipated fees are \$715,597, which is 9.5% of the actual project cost.

Regent Bustos moved to approve the architect selection for the Aviation Maintenance Building expansion project at ENMU-Roswell as presented. Regent Birmingham seconded the motion. Vote: Ruiz – Yes; Birmingham – Yes; Wilbanks – Yes; Pyle – Yes; Bustos - Yes. Motion approved.

3. ENMU-Ruidoso Room and Board Rates FY26

Dr. Ryan Trosper recognized that this room and board approval is a bit off-cycle; however, due to recent natural disasters and the growth in enrollment, the need has arisen for student housing. A total of seven housing units have been secured at a hotel in Ruidoso and will be overseen by a staff member who lives on-site.
