Terms and Conditions

This agreement allows ENMU-Portales and ENMU-Ruidoso certificate or degree-seeking students to combine their ENMU (home school) coursework with their host school coursework to meet requirements for Federal Student Aid (FSA) assistance. ENMU will calculate and disburse the FSA awards. All coursework at each school must apply to the student's ENMU-Portales/ENMU-Ruidoso degree plan.

- 1. A consortium agreement is not necessary between ENMU-Portales and ENMU-Ruidoso campuses.
- 2. Students must be enrolled in at least 6 credit hours at ENMU-Portales/ENMU-Ruidoso for fall or spring semesters; 3 credit hours are required for the summer semester.
- 3. Students must not take more hours at the host school than they take at the home school (ENMU).
- 4. Students must meet all FSA eligibility requirements at ENMU-Portales/ENMU-Ruidoso including the Satisfactory Academic Progress policy.
- 5. Repeated coursework must meet aid eligibility requirements to apply to the consortium agreement.
- 6. Students must meet financial requirements of the host institution. This may include meeting payment requirements at the host school prior to the home school's FSA disbursement.
- 7. Complete withdrawal from both ENMU-Portales and ENMU-Ruidoso and the host institution will result in a return of Title IV funds calculation.
- 8. Complete withdrawal from ENMU Portales/ENMU-Ruidoso will void the consortium agreement.
- 9. Students must submit an official transcript from the host school at the end of the semester.
- 10. Students must submit a copy of the host school's course schedule and billing statement.
- 11. Deadline for completed, signed consortium agreements with required documentation is 5 p.m. on the last day to drop/add for the semster.
